ORDER OF DISMISSAL

This proceeding under the Wagner-Peyser Act of 1933, as amended, 29 U.S.C. §49k, and the implementing regulations at 20 C.F.R. Part 658, was initiated at the request of the Complainant for review of a determination by the Regional Director, Office of Civil Rights.

On August 15, 1983, the Complainant notified this Office of his withdrawal of his request for hearing. By letter filed September 7, 1983, the Respondent, Ohio Bureau of Employment Services, notified this Office of its consent to the withdrawal of Complainant's appeal (see attachments). In accordance with 20 C.F.R. 658.425 (d)(2), this proceeding may be dismissed upon the written consent of the parties.

Accordingly, it is hereby ORDERED that the hearing request in the above-captioned matter is WITHDRAWN and this proceeding is DISMISSED.
