

ORDER OF DISMISSAL

This case arises under the Job Training Partnership Act (JTPA) (29 U.S.C. § 1579 et seq.) and the applicable regulations issued at 20 C.F.R. Part 636.

On January 26, 1990 the Department of Labor (DOL) notified Complainant of a disallowance **in the** amount of **\$1,001.00** as a result of **DOL's** audit of Complainant's programs under JTPA. By letter filed June 18, 1990 Complainant requested a hearing on the final determination. On July 3, 1990 this office issued a Notification of Receipt of Request for Hearing and Pre-Hearing Order which required both parties to furnish information regarding this case. On August 1, 1990 Complainant filed a Notice of Intent to Participate and on August 6, 1990 DOL filed the Grant Officer's Administrative file as required. On September 13, 1990 DOL filed a Pre-Hearing Statement in this case. On July 30, 1992 this office issued an Order to Complainant to Show Cause why a default judgment should not be entered in this case.

Complainant filed a response to the Show Cause Order on August 28, 1992. Complainant withdraws its Notice of Intent to Participate stating that the monetary dispute present in this case has been resolved as part of a larger repayment settlement. As an attachment to its response to the Order to Show Cause Complainant included a stipulation executed by both parties, which states in pertinent part, "**{u}**pon execution of this Agreement, both parties will seek dismissal of case number 90-JTP-28 . . .with prejudice." Accordingly, this matter is DISMISSED with prejudice.
