ORDER GRANTING STAY


how before me is the Reply of the Grant Officer to a letter from **the Appellant** requesting a stay of the implementation of the Administrative Law Judge's decision and order of August 6. The case is now pending before the United States Court of Appeals for the Tenth Circuit in ORO Development Corporation v. United States Department of Labor, 84-2370.

Upon consideration of the matter, I am persuaded that the Appellant's request should be granted.

Accordingly, it is ORDERED:

1. That the above referenced decision is STAYED pending review, of it by the U.S. Court of Appeals for the Tenth Circuit; and
2. That the stay IS CONDITIONED UPON the submission by the **ORO** Development Corporation to the U.S. Department of Labor, within 30 days of the date of issuance of this Order, of a supersedeas bond in the amount of \$43,799 which the Administrative Law Judge determined was properly disallowed and was to be repaid to the Department, and for such further amount as may accrue in interest due during the **pendency** of said review, at the interest rate(s) which this Department would normally charge for delayed payment of the principal amount during that period; and that
3. Within 30 days of the issuance of this Order, of a written agreement by the Appellant that, within 30 days following the Tenth Circuit's final decision in this matter, if favorable to the U.S. Department of Labor, that the Appellant agree to comply with the order of the Secretary of

Labor and pay to the Department the principal amount determined by the Court to be owed to the Department of Labor, and such further amount as may accrue in interest during the **pendency** of said review, at the interest rate(s) which the Department would normally charge for delayed payment of the principal amount during that period.
