Order Granting Stay

Respondent New York Urban Coalition's request that the decision of Under Secretary Ford B. Ford of May 10, 1985 in this case be vacated or remanded is DENIED. Respondent's request that enforcement of that decision be stayed pending judicial review is GRANTED, effective-when the following conditions have been met:

- (1) Respondent has filed a timely petition for review in the court of appeals and has served all parties and the Secretary with a copy of that petition;
- (2) Respondent has submitted a supersedeas bond in the amount of \$6000 to the U.S. Department of Labor, the approximate amount of back wages due under the Under Secretary's order, and for such further amount as may accrue in interest during the pendency of judicial review, at the interest rate(s) which the Department of Labor would normally charge for the delayed payment of the principal amount during that period; and
- (3) Respondent has submitted a written agreement that, within 30 days of a final decision by the court of appeals favorable to the Department of Labor, respondent will comply with the Under Secretary's order and pay Ms. Bate back wages with interest for the period specified in that order.
