ORDER DISMISSING CASE

On June 6, 1988, I issued a Notice of Receipt of Document and Request for Clarification in this case. In light of the correspondence from counsel for Cleveland County, Oklahoma, expressing his view that certain transactions concerning the audit proceedings in this case had effected an end to this matter, I requested the parties' views as to whether this case should be dismissed.

Counsel for ACTION, INC., responded on June 13, 1988, and stated "**Action's** understanding ... that this matter has been settled in its entirety, there are no outstanding issues, and proceedings before you can be dismissed." On June 23, 1988, the Associate Solicitor for Employment and Training Legal Services advised me in writing of his concurrence that this matter was concluded and could be dismissed.

Accordingly, upon consideration of the record and the representations of counsel for the respective parties in interest, this case IS DISMISSED.
