

ORDER DISMISSING CASE WITH PREJUDICE

In January 4, 1989, I received from the parties a Joint Motion to Dismiss this case. The parties stated that they have reached a settlement and appended a copy of the Settlement Agreement to the motion. Thereafter on January 7, 1989, I was asked to withhold acting on the motion pending compliance with one of the terms of the agreement. On February 22, 1989, counsel for the Grant Officer notified me that the settlement term in question had been met and requested that I act on the motion to dismiss.

Accordingly, upon consideration of the parties' filings, the joint motion is GRANTED and this case ^{1/} is dismissed with prejudice.
