Pursuant to the October 25, 2006 Minute Order, the parties respectfully submit this Joint Status Report. As a result of the Opinion issued by the Ninth Circuit Court of Appeals in *Leon v. IDX Systems Corp.*, No. 04-35983 and No. 05-35426, the parties agreed that the only remaining issue before this Court deals with Defendant IDX's motion to enjoin Dr. Leon and the United States Department of Labor in connection with Dr. Leon's proceeding before Labor. 
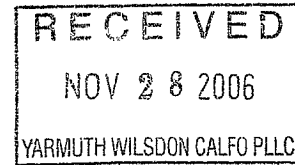

The parties have filed a joint stipulation for the dismissal of this matter. The decision of the U. S. Court of Appeals for the Ninth Circuit in a related case, *Leon v.
