ORDER GRANTING EXTENSION OF TIME

Complainant in this matter, the North Carolina Department of Commerce (hereinafter "North Carolina") filed a Motion for Extension of Time in which to file its prehearing exchange. North Carolina states that it has not yet received the administrative file, and therefore is "not yet in a position to file its prehearing exchange." The response was originally due on September 10; North Carolina now requests that this office grant it forty-five additional days.

Upon inquiry, this office learned that Respondent, the U.S. Department of Labor (DOL) has contacted North Carolina and straightened out the problem with the administrative file. DOL expressed no objection to the request for an extension.

North Carolina's motion is GRANTED. It is hereby ORDERED that North Carolina file its prehearing exchange within **forty-five** days of the date of this order.
